### **GUIDE FOR AUTHORS**

#### **AUTHORS GUIDELINES FOR MANUSCRIPT PREPARATION**

Authors should submit their contributions electronically through the Journal website submission system to the Editorial Office:

### Manuscript preparation

- A typical submitted manuscript will not exceed 7000-8000 words including tables.
   Manuscripts that greatly exceed this will be critically reviewed with respect to length.
   Authors should include a word count with their manuscript.
- Manuscripts should be compiled in the following order: title page (including
  Acknowledgements as well as Funding and grant-awarding bodies); abstract; keywords;
  main text as; introduction, methodology, results and discussion, conclusion, conflict of
  interest, Acknowledgement and references. Please supply all details required by any
  funding and grant-awarding bodies as an acknowledgement in a separate Funding
  paragraph as follows:
- Abstracts of 200-400 words are required for all manuscripts submitted. The Abstract composition must be structures as: BACKGROUND AND OBJECTIVES + METHODS + FINDINGS + CONCLUSION.
- Each manuscript should have 4 to 7 keywords.
- All authors of a manuscript should include their full names, affiliations, postal addresses, telephone numbers and email addresses on the cover page of the manuscript. One author should be identified as the corresponding author. Please give the affiliation where the research was conducted. If any of the named co-authors moves affiliation during the peer review process, the new affiliation can be given as a footnote. Please note that no changes to affiliation can be made after the manuscript is accepted. Please note that the email address of the corresponding author will normally be displayed in the article PDF (depending on the journal style) and the online article.
- All persons who have a reasonable claim to authorship must be named in the
  manuscript as co-authors; the corresponding author must be authorized by all coauthors to act as an agent on their behalf in all matters pertaining to publication of the
  manuscript, and the order of names should be agreed by all authors.
- Biographical notes on contributors are not required for this journal.
- Authors must adhere to SI Units. Units are not italicised.
- Authors must not embed equations or image files within their manuscript.

# **Figures**

- Please provide the highest quality figure format possible. Please be sure that all imported scanned material is scanned at the appropriate resolution: 1200 dpi for line art, 600 dpi for grayscale and 300 dpi for color.
- Files should be saved as one of the following formats: TIFF (tagged image file format), PostScript or EPS (encapsulated PostScript), and should contain all the necessary font information and the source file of the application.
- All figures must be numbered in the order in which they appear in the manuscript (e.g. Fig. 1, Fig. 2). In multi-part figures, each part should be labelled (e.g. Fig. 1(a), Fig. 1(b)).
- Figure captions must be saved separately, as part of the file containing the complete text of the manuscript, and numbered correspondingly.
- The filename for a graphic should be descriptive of the graphic, e.g. Fig. 1, Fig. 2(a).

#### Citation

Reference citations in the text should be identified by the surname(s) of the author(s) and the year of publication.

- If there is no author, use the title (or a short form of the title, if it is lengthy) and the year.
- If there is no date, use "n.d." (without quotation marks) instead.

#### Some examples:

- Since the 1960s, East Asia has become the most common term for the region in international mass media outlets (Reischauer and Fairbank, 1960).
- This paper discusses the risk factors identified within the system at all the railway stations in Tehran (Rabbani *et al.*, 2008).

#### Reference list

- The list of references should only include works that are cited in the text and that have been published or accepted for publication. Personal communications and unpublished works should only be mentioned in the text. Do not use footnotes or Endnotes as a substitute for a reference list.
- Reference list entries should be ordered alphabetically.
- The reference list should be written in the IJHCUM Journal reference writing style.
- The reference list should consist applicable information: author(s) name(s), journal title/book title, chapter title/article title, year of publication, volume number/book chapter and the pagination must be present. Use of hyper;ink for each reference is highly encouraged.
- All the journals names in the references must be provided with hyperlinks. The journals abbreviations can be found in the below link:

# Manuscript submission

All submissions should be made online at the International Journal of Human Capital in Urban Management Website. New users should first create an account through registration. Once logged on to the site, submissions should be made via submit papers available on the website. Manuscripts may be submitted in any standard editable format, including Word and EndNote.

# Copyright and authors' rights

To assure the integrity, dissemination, and protection against copyright infringement of published articles, you will be asked to assign us, via a Publishing Agreement, the copyright in your article. Your Article is defined as the final, definitive, and citable Version of Record, and includes: (a) the accepted manuscript in its final form, including the abstract, text, bibliography, and all accompanying tables, illustrations, data; and (b) any supplemental material hosted. Our Publishing Agreement with you will constitute the entire agreement and the sole understanding between you and us; no amendment, addendum, or other communication will be taken into account when interpreting your and our rights and obligations under this agreement.

### **BEFORE YOU BEGIN**

### **Ethics in Publishing**

The ethical policy of IJHCUM is based on the Committee on Publication Ethics (COPE) guidelines and complies with International Committee of IJHCUM Editorial Board codes of conduct. Readers, authors, reviewers and editors should follow these ethical policies once working with IJHCUM. The ethical policy of IJHCUM is liable to determine which of the typical research papers or articles submitted to the journal should be published in the concerned issue. The publishing decision is based on the suggestion of the journal's reviewers and editorial board members. The ethical policy insisted the Editor-in-Chief, may confer with other editors or reviewers in making the decision. The reviewers are necessary to evaluate the research papers based on the submitted content in confidential manner. The reviewers too suggest the authors to improve the quality of research paper by their reviewing comments. Authors should ensure that their submitted research work is original and has not been published elsewhere in any language. Applicable copyright laws and conventions should be followed by the authors. Any kind of plagiarism constitutes unethical publishing behavior and is unacceptable. For information on this matter in publishing and ethical guidelines please visit http://publicationethics.org.

#### **Peer-Review Process**

In order to sustain the peer review system, authors have an obligation to participate in peer review process to evaluate manuscripts from others. When appropriate, authors are obliged to provide retractions and/or corrections of errors to the editors and the Publisher. All papers submitted to IJHCUM journal will be peer reviewed for at least one round. IJHCUM journal adopts a double-blinded review policy: authors are blind to reviewers, but reviewers are not blind to authors. The peer review process is conducted in the online manuscript submission and peer-review system. After a manuscript is submitted to the online system, the system immediately notifies the editorial office. After passing an initial quality check by the editorial office, the manuscript will be assigned to two or more reviewers. After receiving reviewers' comments, the editorial team member makes a decision. Because reviewers sometimes do not agree with each other, the final decision sent to the author may not exactly reflect recommendations by any of the reviewers.

The decision after each round of peer review may be one of the following:

- 1. Accept without any further changes.
- 2. Accept with minor revision. The revised manuscript may or may not be sent to the reviewers for another round of comments.
- 3. Decline with resubmission encouraged. Major changes are necessary for resubmission. The revised manuscript will be peer reviewed for another round. Typically, it will be sent to the original reviewers.
- 4. Decline without encouraging resubmission. The manuscript is rejected for publication by IJHCUM.

# **English Language Writing**

All publications in the IJHCUM are in English language. Authors whose first language is not English should make sure their manuscript is written in idiomatic English before submission. Please write your text in good English (American or British usage is accepted, but not a mixture of these). No language and copy-editing services are provided by the IJHCUM; hence, authors who feel their manuscript may require editing to eliminate possible grammatical or spelling errors are encouraged to obtain such services prior to submission. Authors are responsible for all costs associated with such services.
